TOTAL BODY PHOTOGRAPHY & AI ASSISTED MONITORING (TBP-AIM) INTAKE FORM

TREATMENT INFORMATION

Total Body Photography and Artificial Intelligence-assisted Monitoring (TBP-AIM) are specialized techniques to aid in the monitoring for changes to skin lesions/moles/nevi. This monitoring works for pigmented lesions, with the goal of early identification of potentially malignant lesions, like melanoma. TBP-AIM is not for general skin rashes or difficult to see non-pigmented lesions.

Skin screening like this may not equally benefit all people, but any person could benefit if it is of interest to them. Those most at risk of melanoma, and who would find the greatest benefit from formalized skin surveillance and monitoring, are:

- those with many (+50) atypical appearing moles
- those with a close relative with melanoma
- those with previous personal diagnosis/biopsy of melanoma
- fair or red-haired, light skin individuals
- those with a history of significant UV exposure or sunburn

As TBP-AIM utilizes photography and artificial intelligence (AI) to track skin lesions, any lesions located in areas that are not photographed may be missed (genitals, mouth/mucous membranes, scalp etc), and by enrolling in this program, you understand this risk. If you are enrolled when your photographs are reviewed with the physician, you will have the option to have these more difficult to assess areas examined. Even with an exam, these areas are potentially difficult to fully visualize and thus, lesions may be missed. If you or anyone else has identified a lesion of potential concern in a non-photographed area, please bring this to the attention of the provider during your consult.

If at any time lesions are identified as requiring medical management (including biopsy), you will be advised, and a separate appointment will be made for biopsy as appropriate. Such management or further investigation will be covered by Alberta Health Care (or other provincial health plans). If you choose to have lesions removed for cosmetic reasons, those reasons are not covered by Alberta Health Care, and removal of these lesions will have a procedural fee. Cosmetic treatment is optional, and you will be advised of any costs before any elective procedure is booked.

TBP-AIM may have partial coverage under certain private health benefit plans, but our clinic assumes no responsibility for determining or guaranteeing acceptance. We are happy to provide a general letter detailing the program and the potential health benefits that you can provide to your insurance company for investigation of possible coverage. Any forms required in addition to our office's general letter will incur a fee, respecting the Alberta Medical Association Uninsured Services Guidelines.

It is always important to be aware of your own skin and monitor it for changes then report to your health provider. TBP-AIM is an additional tool to assist you in your health surveillance.

(Please choose one) 3 or fewer lesions of most concern Focused Program - \$75 intake assessment fee, and later \$50/year for follow-up monitoring for any of the initial 3 or fewer lesions that remain 4 or more lesions over many areas of the body • Total Body Photography Total Program - \$250 initial assessment fee, and later \$200/year for ongoing follow-up assessments TBP-AIM only has a private pay fee to cover the hardware/software costs of capturing and storing images to map and monitor for concerning changes. You are not charged for the services provided by the physician/s in reviewing your photographs or assessing and discussing management of your lesions, this part is covered by AB provincial health coverage. However, as our physicians are not Dermatologists and have other practice demands, yearly total skin surveillance checks will only be available through the TBP-AIM program. An alternative to our TBP-AIM Program: you may ask your primary care provider if they are comfortable completing yearly skin screening or have your primary care provider refer you to a specialist Dermatologist for this service. If you have 3 or fewer lesions you would like assessed, without ongoing yearly monitoring, you are welcome to get a referral to our clinic for a regular Cutaneous Lesion Assessment.
